ANNOUNCEMENT

On the eve of the Five Hundreth Anniversary of the Encounter of Two Worlds, the CONGRESS OF NEGRO CULTURE OF THE AMERICAS is taking place with the object of throwing a spotlight on black contribution to the cultural identity of the American continent.

Blacks in the Americas and their part-Indian and part-European mixed blood offspring, represent a creative force imbued with new values that deeply influenced the social and cultural development of the American continent and enriched the cultural heritage of mankind as a whole.

Because of its historical ties with the Americas, Europe is particularly receptive to these contributions, which include: ideological and practical dimension of freedom struggle, religious syncretisms, liberation theology, the concept of family within the extended family structure, the ethnic imperative as a basis of social identity, new expressions in music, danse, literature and other esthetique forms, as well as decisive contributions to science and tecnology through the empirical knowledge of Indian and Afro American cultures.

The timing of the Congress is thus most opportune especially in view of the fact that the new nature of the international relations admits as a norm the sharing of the achievements of modern science and technology against a background of mutual respect and equal status of diverse world cultures and ethnic groups.

STRUCTURE AND ANTECEDENTS

These were occasions that brought together historians, ethnologists, artists, and popular delegates (representative of Black and Indian communities, peasants, craftsmen) to, methodically develop an understanding of the contributary elements of black and mulatto cultures.

THE GOAL OF THE CONGRESS OF NEGRO CULTURE IN THE AMERICAS IS TO

- Develop research in the ethnographic, social, economic, and artistic fields into the historical role of Blacks in the Americas.
- Raise the problem of African contributions and the value of such contributions from the perspective of the feelings and aspirations of the black population.
- Establish a common front of scholars involved in research on black culture in the Americas.
- Bring contribution to the improvement of social and cultural condition of Afro American Communities, by setting up specific projects funded by Non governmental Organizations.
- Create institutions in each country in the continent devoted to research on Afro American cultural values, and develop exchanges between these institutions and similar organisations in Africa and the rest of the world.

THEME OF THE FOURTH CONGRESS

Within the parallel perspective of the five hundreth anniversary of the Encounter between two worlds and the establishment of the European Community, the Congress will adopt a multidisciplinary approach to an examination of black culture in the Americas and provide a forum for the expression of different points of view by delegates from America, Africa and Europe.

The Congress, which will be placed under the auspices of UNESCO, will aim at renewing and broadening the scope of previous debate in this field.

1 - THE BLACK AMERICAN IMPACT ON EUROPEAN DEVELOPMENT

Afro American intellectual and material contributions to European development

2 - THE BLACK CULTURAL PRESENCE IN THE AMERICAS

The instruments of liberation and creativity of the new Afro American identity: plastic arts, literature, religious syncretisms, philosophy and science.

3 - FIVE HUNDRED YEARS OF MUTUAL INTERPENETRATION

- Ethnic groups, social struggles, economic discrimination, power...
- The interpenetration of American peoples : a pointer to the Future.

4 - THE CHALLENGE OF CONTEMPORARY TECHNOLOGY

Science and traditional empirism: ecology, technological transfers, creativity of empirical peoples and their contributions to the heritage of mankind.
